Dear Sir/Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that **Automotive Axles Limited** (“*The Company*”) has received a notice dated 28th February 2025 on 18th March 2025 from the **Karnataka State Pollution Control Board (KSPCB)** regarding mandatory retrofitting of Emission Control Devices (RECD) or shifting to gas-based generators for Diesel Generator (DG) sets of capacity 125 KVA and above at the Plant situated at Mysuru, Karnataka.

As per the said notice, the Company is required to ensure compliance with the prescribed emission control measures within the stipulated timeframe and submit an action taken report within 7 days from the date of receipt of the notice.

The Company is in the process of assessing the necessary steps to ensure compliance with the regulatory requirements and will take appropriate measures within the prescribed timeline.
